The oath to testify in court. Before testifying in any court or legal proceedings, witnesses must answer in the affirmative to the following oath: "Do you swear to tell the truth, the whole truth and nothing but the truth so help you God?" Other oaths can also be taken, such as:

Examples of Oaths

Oath: Do you solemnly (swear/affirm) that you will tell the truth, the whole truth, and nothing but the truth, (so help you God/under pains and penalties of perjury)? "Swear" may be replaced with "affirm", and either "so help you God" or "under pains and penalties of perjury" may be used; all oaths and affirmations are considered to be equivalent before the law.
